The group has grown and is now comprised of members from six partner organizations – the Thunder Bay Community Foundation, the Northern Ontario School of Medicine, St. Joseph's Foundation, Thunder Bay Regional Health Sciences Foundation, Confederation College and The George Jeffrey Children's Foundation.

"We're hoping people will think about making a gift in their Will so future generations have access to exceptional healthcare, outstanding education and supportive social services, in our community," said Terri Hrkac, Sr. Director, Thunder Bay Regional Health Sciences Foundation. "That's why our organizations joined together to form Legacy Giving Thunder Bay – we want to educate and inspire people on the benefits of legacy giving."


Legacy Giving Thunder Bay is specifically able to help you when you may think:

"I also think it's important that the donor speak with the organization(s) where they wish to designate their gift(s)," said Gail Brescia, Executive Director, St. Joseph's Foundation "When donors are able to speak with us, we can help them decide, exactly, how they wish to designate their gift so that it reflects their beliefs and passions."

"Additionally, when donors let us know their intentions, we can better thank and honour them in their lifetime," added Brescia. "We have the very trusted role of ensuring that a person's life or family's history is preserved through this gift, and when we can talk with them in advance, we can provide the reassurance that their gift will be used exactly as they envision."



## THUNDER BAY COMMUNITY FOUNDATION

The Emergency Community Support Fund, a partnership of the TBCF and the United Way of Thunder Bay, has provided over \$1.3M in grants to date to organizations around the city. In the first round of funding, over 20 local charities received funding for various projects that ranged from food security programs to building/technology upgrades.

Grace Place Thunder Bay was one of the many local charities that received a grant of \$11,983.50 through the Emergency Community Support Fund (ECSF).

With increased COVID-19 barriers in place, they can move back to indoor serving with increased safety. They have also been able to offer those in our community a Day Shelter. With the added funding, Grace Place has been able to offer 3 meals 4x a week for clients. During this time, clients can access a hot shower, a free haircut, and a mat to sleep during the day.

In October 2020, TBCF announced a second round of the ECSF. A total of \$318,533 is being distributed through the second round to support organizations in Thunder Bay and the district areas.

Charities and non-profit organizations have been providing essential services and programs since the pandemic was first declared. This emergency support for their work is vital, as is longer-term support so they can be around to help see our communities through the recovery from COVID-19.



## THUNDER BAY REGIONAL HEALTH SCIENCES FOUNDATION

From milking cows as a child, to helping her family farm chickens, and then, later, finding a passion for gardening and flowers, Isabel Webster's life was one that will always be remembered by those who knew her. And now, thanks to her decision to make a gift in her Will of \$1,025,128 to the Thunder Bay Regional Health Sciences Foundation, her impact will continue to be felt for years to come.

Isabel expressed her desire of how she wanted her estate to be used. "She wanted it to go to a worthy cause; one that would make good use of it," recalled Effie Rempel, Isabel's cousin and co-executor of her estate. "She was extremely particular," commented George, Effie's husband, "and wanted things just right." He recalled having to dig up some of the 500 gladiola bulbs he had planted to replant them one-quarter inch deeper, since they weren't up to Isabel's standard. "So I can say it was with a lot of thought and trust that she made this donation," he added.

Isabel's gift will be used to create the Isabel Webster Endowment Fund, from which funds will support the Cardiovascular Surgery Program at the Thunder Bay Regional Health Sciences Centre. She was keen to leave a donation to the city where she spent her entire life, to fund a program that could continue to care for people.

when we meet with donors to determine how their gift will play a role in our future,” said Alexandra Calderon, Executive Director, Thunder Bay Community Foundation. “We find that once donors become more aware of the impact and ease of leaving a gift in their Will, they frequently wish to give to several charities. Our group is very keen on working together to ensure that donors in our community are well-informed about the options they have when choosing where to assign their gift, and I think it’s important that donors are aware that we’re working collaboratively. There’s no competition between us as charities because we know it’s the overall spirit of philanthropy that makes a community great and we want to encourage that specifically.”

“Conversations about legacy giving aren’t always the easiest to have,” added Hrkac, “but I think people can feel more comfortable knowing there’s a group in our community who are presenting this information in a way that highlights the importance of legacy gifts, without pressure for a gift to any one particular organization. We truly want to work together, with donors, to better services in Thunder Bay – and we’re proud of the work we do collectively.”

## Why People Don’t Leave A Gift In Their Will: Some Common Myths

Your Will can be a powerful tool for creating change in your community. By leaving a gift in your Will to a charity you are passionate about, you can have a much bigger impact than you can imagine. Unfortunately only 5% of Canadians take this step. Why? There are some common myths that typically get in the way of people making this decision.

### ***I can’t support both loved ones and my favourite charity***

Most people choose to leave everything they have to their family and loved ones. On the surface that makes sense. However, a careful calculation can demonstrate that a small percentage of your estate left to charity still leaves enough for you to support your loved ones.

The reality is that your estate will be taxed. Choosing to support the charities of your choice can reduce, and in some cases eliminate, the taxes to be paid. Your accountant or financial advisor can help navigate this for you.

### ***I need to be wealthy to leave a gift in my Will***

The majority of charitable gifts in Wills are left by Canadians of average means. You may be surprised to find that when all your assets are realized, you too will have enough for both your loved ones and your selected charities.

### ***Leaving a Gift in my Will is complicated***

Remembering a charity in your Will is an act that is generous, powerful and surprisingly simple. When meeting with your Lawyer to either draft or revise your Will, have the conversation about adding a charity to receive an amount or a percentage of your estate. Every gift in every Will makes a difference.

### ***I will never see the impact of the gift I leave in my Will***

It can be discouraging to think that you will not be around to see the impact of the gift you leave in your Will. You would rather do what you can now. Absolutely, however for most people, you will never be able to make as big a gift while you are alive as you can through your Will. Here are three ways you can see the impact your future gift will have.

- Many donors give smaller gifts to the causes they love when they’re alive. They become engaged with the charity so they get a feel for what the impact of their future gift will be – when they are able to give a much larger gift from their estate.
- By letting your charity know that you’ve included them in your Will, they will be able help you get a sense of the impact your future gift will have.
- Finally, a gift in your Will can help your family feel part on the impact you are making, as many charities involve the family in the implementation of the gift. Planning your gift now can be a comfort knowing your loved ones will have a meaningful way to remain connected with you and the charity that you were passionate about.
